An Update on How You've Helped **Open Doors** to Accessible, Affordable "Housing with Care®"

What we did together in 2017:

Completed Patriot Place Apartments in Las Vegas, Nevada, a new accessible, affordable 50-unit home for veterans, homeless veterans and veterans with physical disabilities. **Dedicated** Voyageur Apartments, in Great Falls, Montana, with Ken Berry, ASI's Director of Property Management, welcoming guest speakers the Honorable Bob Kelly, Major, City of Great Falls; Jeff Arbizzani, Market President, Helena, Montana; U.S. Bancorp; Steve Harns, resident of Voyageur Apartments; and the Honorable Steve Bullock, Governor of Montana. **Assumed** management of Ruby Duncan Manor, a 30-unit Las Vegas property for low-income seniors.

Renovated and remodeled 15 of the Winston Court and Red Ruth Apartments in Hibbing and Duluth, Minnesota, including new carpeting, vinyl flooring and appliances in the resident units and repairs to the building structure including modernization of the elevator, siding replacement and replacement of the boiler. Replaced building windows at Galaxy Apartments in Rapid City, South Dakota. Upgraded the elevator at Eagle Watch Estates in Missoula, Montana. The Nevada Community Enrichment Program (NCEP) **redesigned** a pool house so additional bedrooms could be added to Hastings House and **expanded** therapy space for rehabilitation equipment at NCEP by removing the old swimming pool.

Increased services in Minnesota and Nevada to provide supportive care to over 400 very low-income adults with physical disabilities and/or brain injuries, as well as services allowing seniors to age in place. In addition, residents and service recipients lacking basic living necessities have access to the Pat Hervey Fund providing for emergencies and opportunities for expanded community integration activities at the zoo, state and community fairs, concerts, sporting and theater events, shopping, dining out and volunteering.

Inspired participation at donor-sponsored, mission support events. Accessible Space volunteers planned and invited friends, family, co-workers and business partners to **A Taste for Space** in Minneapolis and **Let's Open Some Doors** mission support luncheons in Las Vegas, Nevada and St. Paul, Minnesota helping us raise nearly **\$175,000!** **Celebrated** the Nevada Community Enrichment Program's 25th Anniversary and our President/CEO, Stephen Vander Schaaf's 35th anniversary. Thank you for helping us share our mission with hundreds of new people at these events.
