An Update on How You've Helped **Open Doors** to Accessible, Affordable "Housing with Care®"

What we did together in 2019:

Opened Allegiance Apartments in Las Vegas, Nevada, a new accessible, affordable 50-unit home for low and very low-income veterans, homeless veterans and veterans with physical disabilities.

Added three supportive living arrangement (SLA) houses in Nevada providing supportive care to nine individuals with disabilities in residential communities.

Started construction on the Nevada Community Enrichment Program's (NCEP) Spencer Street Campus and Stepping Stone Apartments, both located in Las Vegas, Nevada, adding 32 units and rehabilitation space for people with traumatic and acquired brain injuries.

Renovated and remodeled six locations, home to 120 people, with new roofs, siding, windows, doors, stucco, cement, carpet, flooring, landscaping, raised gardens, lighting, heating, air conditioning, plumbing or elevators in Minnesota, Montana, Nevada and South Dakota.

Provided care services to **assist, support and encourage** over 400 low-income people with mobility disabilities and brain injuries, as well as seniors and veterans, to achieve their personal goals and their highest level of desired independence.

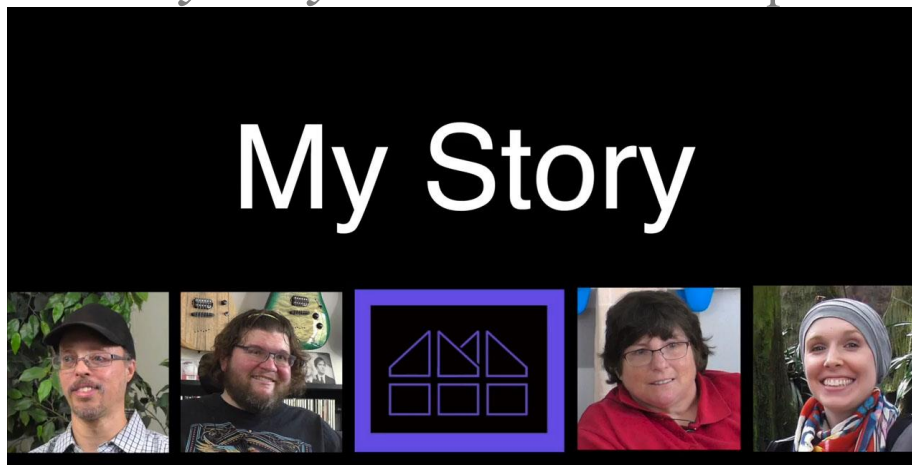
Upgraded technology for resident computer labs and for employees to better track client cares.

Inspired participation at donor-sponsored, mission support events as we **celebrated** ASI's 41st year. Accessible Space, Inc.'s Fund Development Advisory Committee and other volunteers planned and invited friends, family, co-workers and business partners to ASI's annual **Let's Open Some Doors** Mission Support Luncheon in St. Paul, Minnesota in October, helping us raise funds from generous luncheon guests, invitees and year-end supporters and helping us share our message throughout 2019 to hundreds of people. **92.2%** of all funds raised throughout the year go directly to our mission.
